## Workshop Information

#### Workshop 1 – Finding your latitude & longitude

The Local Compact & it's Champions – what are they and what can they do for you? The Local Compact For: Working Together in Warrington sets out the principles that public sector bodies and third sector groups and organisations should follow when working together in partnership. This workshop will introduce the Local Compact, what it is and how it can be used on a practical basis.

This work shop is best for members of organisations that regularly work in partnership with colleagues from another sector or type of organisation. It is an introductory session for those that have never attended previous Compact presentation and / or workshops.

#### Workshop 2 - Trawling for Money

Funding - What's it all about?

This workshop will take a look at what grant funding is all about, it will explore a range of funding opportunities and funding bodies, and will give you tips on what you can do to improve your chances of being awarded a grant. It will look at what grant funding panels look for when assessing grants and you will learn techniques to help you improve your chances when approaching a funder for a grant. This workshop will particularly be useful to those who are part of a smaller voluntary organisation with very little experience or knowledge of applying for funding.

### Workshop 3 – What else is in the local Treasure Chest?

Asset transfer, what is it? - A local case study, is it for you?

Warrington Disability Partnership and Warrington Borough Council were jointly successful with a Big Lottery Community Asset Transfer bid for WBC to renovate their Centre for Independent Living and hand back to WDP on a peppercorn rent. A working group has been set up to look at potential future Asset Transfers and this Workshop is for anyone interested in the 'lessons learnt' as well as any potential 'Future Asset Transfers'.

#### Workshop 4 - Changing Tides

Personalisation agenda - what is it? What does it mean for third sector organisations?
